

FIREARM TRANSFER-IN POLICY

- 1. **Notification**: Inform the shipping dealer that you wish to have the firearm transferred through 88 Tactical. If the shipping dealer needs a copy of our FFL/SOT, they can request one by emailing us at Retail@88Tactical.com.
- 2. **Pickup Requirements**: To pick up your transfer, you must fill out the ATF Form 4473 electronically in-store. You will need to provide a Photo ID and proper certification documents. The State of Nebraska requires a Concealed Handgun Permit or Firearm Purchase Certificate for handguns or items considered "Other Firearms". A NICS background check can be submitted for long guns.
- 3. **Transfer Fee**: Our FFL/SOT Transfer Fee is \$40 per serialized handgun, long gun or "other firearm". Our NFA Transfer Fee is \$65 for each NFA serialized items.
- 4. **Notification of Arrival**: Once the firearm(s) arrives and we have received it in our system, we will contact you to let you know it is available to pick up. Even if the shipping carrier (FedEx/UPS/USPS) indicates your transfer has been delivered, do not assume the item is ready for pickup.
- 5. **Storage Fees**: If you have not picked up your transfer within 30 days of us receiving it in our system, a \$35 Monthly Storage Fee will be assessed per Firearm until it is processed out of our system. After 90 days, the transferred firearm(s) will be considered forfeit and then will become property of 88 Tactical. If you decide that you no longer want the firearm(s), you will be responsible for initiating the return authorization with the vendor and will also pay the \$40 or \$65 Transfer Fee along with the shipping costs before we initiate the return shipment.

FIREARM TRANSFER-OUT POLICY

- 1. **Verification**: Please contact the FFL/SOT Dealer that you have chosen to send the firearm(s) to before your shipment from us to verify that they are currently accepting transfers.
- 2. **Required Information**: We will need a copy of the seller's license, the buyer's contact information, and the FFL/SOT Dealer's FFL/SOT.
- 3. Fees: You will pay the Transfer Fee associated with your Firearm(s) along with the Shipping Costs.
- 4. **Shipping**: 88 Tactical will charge a shipping fee of \$30 per handgun or "Other Firearm". Long Gun shipping fee will be \$60. We will only ship within the continental United States. We make every attempt to ship your firearm(s) as quickly as possible, and we will provide you with the tracking information once available.
- 5. **Liability**: 88 Tactical is not responsible for any damage once the carrier has taken possession of the transferred product.

PRIVATE PARTY TRANSFER POLICY

- 1. **Recommendation**: For private sellers wanting assurance that the other private individuals are not prohibited from possessing firearms, we encourage you to bring that firearm(s) to 88 Tactical so we can assist with the transfer.
- 2. **Documentation**: The seller or person transferring the firearm will need to provide a Photo ID. The receiving party will need to provide their Photo ID and proper certification documents, either a Concealed Handgun Permit or Firearm Purchase Certificate as required by Nebraska State Law. A NICS background check can also be performed for the transfer of a long gun.
- 3. **Transfer Fee**: A \$65 Transfer Fee will need to be paid for the transaction. It is up to the buyer/receiver to decide who will be the party responsible for payment of the Fee.
